SUPPLIER SECURITY

The service assigns a scorecard that measures cyber-risk, similar to a FICO score for data security.

To ensure data security and privacy throughout our entire supply chain:

- All suppliers are required to achieve a defined level of security
- We continuously monitor risk and vulnerability ratings
- Suppliers must maintain defined ratings to receive business from NuCompass
